1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

The purpose of the grant project was to stock two emergency food and supply pantries at the Buena Clinton Youth and Family Center and the Magnolia Park Family Resource Center in Garden Grove, California. This project also included special food distribution/mobile pantry events at both centers. The project benefitted local families and individuals in need with food and hygiene supplies. The following related activities have been completed:

- On April 12, 2017 and May 9, 2017 supplies were purchased from the 99 Cents Only Store, Costco and Dollar Tree Stores to stock the emergency pantries at the Buena Clinton and Magnolia Park Family Resource Centers. Supplies included: shampoo, toothpaste, soap, deodorant, baby wipes, sanitary napkins, soup and cereal. (See attached receipts)
- Seven food distribution/mobile pantry events were conducted at the Buena Clinton and Magnolia Park Family Resource Centers as follows:
 - Second Harvest Food Drop #1 (9/23/16), #4 (3/31/17), #6 (5/19/17) Magnolia Park Family Resource Center
 - Second Harvest Food Drop #2 (11/28/16), #3 (2/3/17), #5 (4/13/17), Buena Clinton Family Resource Center
 - Corn Distribution, (6/1/17), Buena Clinton Family Resource Center
- 2. How many Rotarians participated in the project?

Ten Rotarians participated in the project: Joe Hammer, AG Anvari, Sylvia Bacolot, Harry Krebs, Tom Schultz, Maria Stipe, Danny Krebs, Steve Larson, Jesse Cho, and Don Alexander

3. What did they do? Please give at least two examples.

AG Anvari served as the primary project coordinator. He met with staff at both the Buena Clinton and Magnolia Family Resource Center to identify needs, plan activities, and coordinate food distribution events. Joe Hammer, Sylvia Bacolot, Harry Krebs, Tom Schultz, AG Anvari, Danny Krebs, Steve Larson, Maria Stipe and Jesse Cho participated in food distribution, pantry stocking activities, took photos and posted updates on the City's Facebook page. Maria Stipe, AG Anvari, Joe Hammer, and Don Alexander assisted with grant administration and progress reporting.

- 4. How many non-Rotarians benefited from this project?
 - The emergency food and supply pantries are estimated to serve approximately 1000 families.
 - The food distribution/mobile pantry events are estimated to have served over 2000 individuals and families.
- 5. What are the expected long-term community impacts of the project?

Families who are food insecure and in need were provided with food and hygiene supplies, allowing them to reduce stress and increase stability within their households. The message of Rotary service was communicated within the community.

- 6. If a cooperating organization was involved, what was its role?
 - Food was provided by Second Harvest Food Bank, Orange County
 - Corn was provided by California Roasted Corn, Midway City, CA
 - Magnolia Park and Buena Clinton Family Resource Center staff worked with GG Rotary to coordinate and support related activities.


