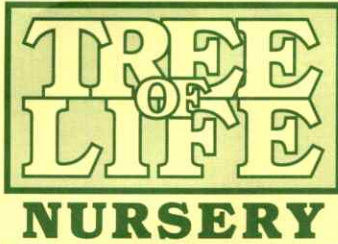

All nursery stock is offered for sale subject to crop yield and prior sale. Limitation of Liability: Tree of Life Nursery's maximum liability, whether contractual or for negligence or otherwise, is limited in amount to the amount paid to Tree of Life Nursery for the purchase of seeds, bulbs or nursery stock under all circumstances and regardless of the nature, cause or extent of the loss. <b>RECEIVING &amp; ACCEPTANCE:</b> Nursery stock and seed are perishable.
