
Boys & Girls Clubs of Huntington Valley (BGCHV) is proud to partner with Surf City Rotary Club of Huntington Beach on several joint projects throughout the year.

We are committed to working with Rotary on the following programs in the upcoming year:

1. **Food Backpack Program.**
BGCHV will operate its Twilight Education Project for low-income non/low English speaking families to get preschool instruction, school age tutoring, ESL classes and job skills training. BGCHV will partner with Rotary to provide families participating in this program with backpacks full of food to help families have enough to eat on the weekend. We will recruit participants for the food backpack part of the program, determine families need and eligibility, provide storage space for the food, distribute the food and help in other ways as needed.
2. **"Shoe the Kids" Program**
BGCHV will partner with Rotary to provide shoes and socks for low income youth. BGCHV will select and sign up participants, including determining need and eligibility of youth. BGCHV will provide transportation to and from the shoe shopping events and a location for the celebration BBQ following shopping events. BGCHV will also assist by sending information to the media about these events and by trying to find additional sources of support to help BGCHV and Rotary reach even more youth in need.
3. **Science Club**
BGCHV will run its after school programs at its school age youth facilities. BGCHV partner with Rotary to present the "Mad Scientists Club" to help engage youth in STEM education as part of BGCHV's after school programming. BGCHV will recruit participants, provide a place for the Club to meet, help provide supplies for Club projects and provide staff to assist with the Club as needed.
4. **Holiday Gift Giving**
BGCHV will run its annual "On Dasher, On Dancer" Toys for Tots style holiday parties for youth in need and we are grateful to have Rotary as an annual sponsor and source of volunteers for this event. BGCHV will provide locations for the parties, recruit and sign up youth in need to participate in the program, provide transportation for youth to the parties, and work with Rotary and other community agencies to provide toys, crafts, a meal, and special holiday experiences for the children.

We are grateful to have Surf City Rotary Club of Huntington Beach as a longstanding committed partner. Thank you for working with us to help give the children in our community both the necessities and those special extras that make childhood fun!
