Stocking an Emergency In-House Pantry at the Buena Clinton Family Resource Center, located in Garden Grove, CA. Purchase shelving for a new storage area for food and provisions at the same site. Restock Magnolia Park Family Resource Center's Emergency Pantry in Garden Grove, CA. Fund 8 food drops @ \$250 each for the families assisted by each resource center.
