1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? A custom mural on a 2-3 feet tall, by 150 foot long, retaining wall that runs on two sides of this small 'pocket park'. All aspects of the project occurred at the park given the stationary nature of the wall. Neighbors directly across from and near the park and mural will benefit as the wall formally was a common target of 'tagging' and mis matched paint to cover it up.

- 2. How many Rotarians participated in the project?
- 7-10 Rotarians were routinely involved in the project
- 3. What did they do? Please give at least two examples.

The wall required SIGNIFICANT preparation and old paint layers had to be scraped, peeled and power washed off. Rotarians were involved in the wall prep and also in painting of the mural with the oversight of the artist himself.

4. How many non-Rotarians benefited from this project?

Many will benefit for we hope many years, the exact number of those that will benefit hard to know.

5. What are the expected long-term community impacts of the project?

We see our involvement at the park (we adopted the park about 18 months ago) as a means of bringing the neighborhood together, build pride in an under-served area and to foster more collaboration within the neighborhood.

6. If a cooperating organization was involved, what was its role?

Students from The Bridge Boxing Club, an after school non-profit, along with students from Maple Elementary school helped on several occasions with coloring in details the artist has sketched for them.
