

We are requesting a matching grant totaling \$3,000 (\$1,500 from the Garden Grove Rotary Club and \$1,500 from District 5320) for the purpose of stocking two emergency food and supply pantries at the Buena Clinton Youth and Family Center and the Magnolia Park Family Resource Center in Garden Grove, California. This project may also include special food distribution events at the Centers. Provisions will include non-perishable food items such as canned food, diapers, baby supplies and personal hygiene items.




