### Panorama general del proyecto

Háblanos sobre el proyecto. ¿Cuáles son sus objetivos principales y quiénes serán sus beneficiarios?

La Plata is a Colombian municipality located in the southwest of the department of Huila. It is located in the foothills of the Central Cordillera bathed by the waters of the Aguacatal, La Plata and Páez rivers. Its territorial extension of 854 km², its height of 1118 meters above sea level and its average temperature of 23 °C. It is the fourth most populous municipality in the department of Huila, after Neiva, Pitalito and Garzón. It is considered as a connection port with the department of Cauca.

Its economic activity is based on agricultural production such as rice, coffee, bananas, cocoa, corn, cane, beans, potatoes; and some fruit trees such as lulo, tree tomato and blackberry (the crops with the highest production). In addition, livestock, the livestock sector and tourist services are important productive systems in the municipality. Villa Lozada is a village of La Plata, with an approximate number of 240 homes and an approximate population of 1,350 inhabitants, increasing with the floating population that transit there. Objectives:

- Contribute to the social and economic reconstruction of the communities.
- Carry out a profound change in the social and economic conditions of Villa Lozada, contributing to the welfare and good living of the rural school population; boys and girls making use of their constitutional rights.
- Access to good quality water in the rural sector as a fundamental right.
- Achieve convergence between the quality of rural and urban life, strengthen links between the city and the countryside.
- Reduce unsatisfied basic needs.
- Contribute to the structural transformation of the rural area of the municipality of La Plata, ensuring the quality of water in rural zones, as a consequence, avoiding child morbidity, gastrointestinal diseases and school absence for these.

### Planificación del proyecto

### Describe las necesidades de la comunidad que abordará el proyecto.

Main need: improve quality of life. Investment in water and sanitation has strong effects in influencing the quality of life of the rural population, preventing diseases, improving nutrition and ensuring care for the environment. This improvement project has an immediate effect on the revitalization of the local economy, since there are related segments of the economy such as agro-industrial processes, dairy production, local markets and, in general, all users of the aqueducts recover the rhythm of their activities, which translates into local economic development.

Reliable water supply and elimination of contamination for disease prevention. The community understands that the current system is providing water contaminated with E coli and coliforms. This means people in general mostly children are frequently ill with diarrhea and other diseases caused by poor water quality.

#### ¿Qué proceso se siguió para determinar estas necesidades?

The needs were identified by the community leaders and communicated to the CR Neiva Noches Plateñas. The community is aware about the problem, inside they have professionals with knowlage, the community leaders, CR Neiva Noches Plateñas and RC Portland pearl members have personally inspected parts of the system and confirmed the deficiencies described. The bacterial water contamination throughout the system was confirmed by bacteriologic testing at a local lab. The water above the intake was confirmed as contaminated probably by people and animals that live there. The water was not chemically contaminated. On the other hand during the meetings a firm with experience in water treatment in rural areas was consulted to determine the work to be carried out, the technical reports were discussed and accepted. Determined optimization for its existing infrastructure, rase awareness about the implementation of water treatment, they can be consius whit the environment and reduce the waste of water. They also agreed that access to purified drinking water (desinfected using chlorine) offered better quality of life to their community.

# ¿Cómo participaron los integrantes de la comunidad beneficiaria en la búsqueda de soluciones?

For more than 30 years, the benefitting community has worked to supply the basic need for access to water, by setting up the Veredal Aqueduct Administration Board (the water committee). They assigned leaders to take charge of the administration of the system, so they have discovered the deficiencies in the system. For this reason they appealed to the members of RC Neiva Noches Plateñas to organize meetings where problems and the various options to solve them were discussed. The community mutually agreed on what is the best way to achieve a sustainable system taking into account economic, technical and water quality factors. In this way, initially the community preferred a filter system in each dwelling. However this alternative was rejected because the filters require constant maintenance and spare parts that were expensive and not easily accessible in the local market. For this reason, the decision was made to resort to a central chlorination system at the source by means of a microbiological treatment stations plants that will be added to the aqueduct. This in addition to the improvements in the pipes and to the concrete structures, guarantee an appropriate solution for the economic, social and environmental conditions of the project.

# ¿Qué participación tuvieron los integrantes de la comunidad local en la planificación del proyecto?

Simple, through leaders pressured by the community. The community was discontented because There is evidence of a high Water Quality Risk Index (IRCA) that affects the health of the community, due to the fact that the community aqueduct does not have the technology, supplies and qualified personnel to carry out the adequate treatment of water for human consumption.

These have generated pressure on the leaders that manage the system, that explain the commitment with the project. So they resolve to engage the water committee to achieve the objectives.

The municipality has different needs associated with public health, including access to drinking water. However, the initiatives by the municipality escape reality, raising budgets enormously and this implies that the community loses control of its aqueduct and it remains in the hands of the government, thus raising costs for the community. This is one of the main reasons to make it sustainable for the community.

# Describe los programas de capacitación, educación o divulgación a la comunidad que abarcará el proyecto.

Training of unskilled labor: Therefore, it is important to make feasible the possibility of generating greater treatment autonomy through the implementation of technology and automation, considering that the infrastructures are far from population centers and rural settlements.

According to the progress of maintenance projects or optimization of water purification systems, it is also necessary to provide not only plumbers but also the water committee with support and training to ensure continuous water quality and effective use of investments made in aqueducts.

Maintenance of the system: it is estimated that the training has a direction of 1 day between 1 to a maximum of 3 hours in which the theoretical and practical knowledge necessary to operate the treatment system will be imparted. In a complementary way, an operation manual will be delivered. The designated person (plumber) will be the same person who today is in charge of the micro aqueduct, the estimated operating times will be once a week for the review and application of chlorine, this operation requires approximately 2 to 5 minutes for each operation. The company gives us an operation and maintenance manual, which the community itself will be in charge of.

### ¿Qué proceso se siguió para determinar las necesidades?

Following the advice of the Community Assessment Tools, we make the first contact through a community leader Interview, this allowed us to gain a deeper understanding of the situation, then this approach was possible with the water committee open to more participants and get technical info about the water and sanitation problems. Finally, the visits made by the different actors made it possible to clearly demonstrate the needs and complaints reported by the community.

# ¿Qué incentivos (por ejemplo: compensación económica, premios, certificaciones o publicidad) se utilizarán para animar a los integrantes de la comunidad a participar en el proyecto?

To encourage the participation of the community in the implementation of the project the benefits of having desinfected drinking water for both human consumption and agribusiness encouraging local economy. Additionally, incentives that the Water Committee has proposed are: 1. economy compensation for the community members working directly on the project as a condition for the local company.

2. Certifications of participation and training on the technologies implemented.

- 4. Experience in the social ecosystem (community management).
- 5. Visit to project place for proposal.
- 6.Legal person with online documentation with the national tax and customs department and who can provide an electronic invoice.

#### Explica por qué.

Because we use the open invitation modality for the purpose of informing local people to refer those interested in participating on the process in particular, the information about the project to be developed; the terms and conditions in which said process will take place and the nature and characteristics to execute, in order to structure a proposal from the Social, technical, legal, economic-financial and results. For this reason, one of the most important duties for the fulfillment of the object of this project is to guarantee the result in water disinfection and not in public service infrastructure, directly or through third parties that ensure the quality of the water in the most efficient way, for its correct functioning and sustainable over time and close to rotary philosophy.

The plan of operation and maintenance of the aqueduct system begins with the inclusion of the personnel of the community that is currently responsible for carrying out this activity in the optimization and improvement process, in such a way that at the same time they will be instruct in the way they will be receive and handle the elements that make up the supply system.

This plan will be developed over throughout implementation. Likewise, a written Manual on the operation and maintenance recommendations will be requested in writing to the equipment suppliers; in this way we will be contributing to the sustainability of the project.

Regarding the microbiological treatment system, the purification system: the ETMUA water treatment plant is a mechanical chlorine dosing system for micro biological treatment, it can be installed at any point of the network, just as it does not need skilled labor for its handling, being easy to handle, other advantage it does not need electrical energy for its operation, one of the main conditions for sustainability and rural zones conditions. For the maintenance plan of the purification system, the provider will perform trainings to the operators including the water committee who and the designated staff for the management for the aqueduct.

# Describe como los integrantes de la comunidad brindarán mantenimiento a los equipos una vez concluidas las actividades de la subvención. ¿Podrán encontrarse repuestos?

The aqueduct infrastructure has been periodically maintained since it was built. The community has been accustomed to paying a monthly fee, so this maintenance can be carried out by one person (Plumber) who knows the subject. The water committee has clear the fee is going to increase a little bit (less than USD1 per house or user) not only for the maintenance but also to pay the plumber to develop his responsibility full time. This fee, which will be distributed for the maintenance of the aqueduct and the purchase of chlorine.

People will cancel according to a criterion of equity that contemplates the level of economic income and the amount of water consumption. In addition new water supply points will be sold at a little higher cost than previously. After grant-funded activities conclude, this will be a low cost operation, managed by the community and with clean and desinfected water as a result.

### Explica por qué.

This kind of equipment has been installed in communities with aqueducts similar to this one and the people have been trained to handle its easy operation, because is a mechanical system which only consists of uncovering a lid of the tank in which the water is purified and adding a specific amount of chlorine. These factors allow for greater confidence that the system will function optimally. Also, previous studies have been carried out in which the place in which the system could be installed was analyzed and since it is small, the space identified for its respective installation has already been identified.

This water treatment system does not require electricity because it works by gravity. Thanks to this characteristic, the community has been more receptive to using this system to make water drinkable and has shown commitment to repair the water flows in their homes.

The community projection in the long term is to offer surplus water from the aqueduct to other communities to gain income. However, it does not consider it necessary at this time or with the implementation of the new system due the low cost maintenance. The new collection fees, determined from the concept of equity, are in the short and medium term, the best income for the sustainability of the aqueduct.

In such an event, the Agreement shall be deemed terminated and the Sponsors shall refund to TRF all unexpended global grant funds within 30 days of termination.
- 5. TRF's entire responsibility is expressly limited to payment of the total financing amount. TRF does not assume any further responsibility in connection with this grant.
- 6. TRF reserves the right to cancel the grant and/or this Agreement without notice upon the failure of either or both of the Sponsors to abide by the terms set forth in this Agreement and the Terms and Conditions. Upon cancellation, TRF shall be entitled to a refund from the Sponsors of any global grant funds, including any interest earned, that have not been expended.
- 7. The laws of the State of Illinois, USA, without reference to its conflicts of laws principles, shall govern all matters arising out of or relating to this Agreement, including, without limitation, its interpretation, construction, performance, and enforcement.
- 8. Any legal action brought by either party against the other party arising out of or relating to this Agreement must be brought in either, the Circuit Court of Cook County, State of Illinois, USA or the Federal District

Court for the Northern District of Illinois, USA. Each party consents to the exclusive jurisdiction of these courts, and their respective appellate courts for the purpose of such actions. Nothing herein prohibits a party that obtains a judgment in either of the designated courts from enforcing the judgment in any other court. Notwithstanding the foregoing, TRF may also bring legal action against Sponsors and/or individuals traveling on grant funds in any court with jurisdiction over them.

- 9. This Agreement binds and benefits the parties and their respective administrators, legal representatives, and permitted successors and assigns.
- 10. If any provision of this Agreement is determined to be illegal, invalid or unenforceable, the remaining provisions of this Agreement shall remain in full force and effect.
- 11. Sponsors may not assign any of their rights under this Agreement except with the prior written consent of TRF.
