Project Overview

Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

With the growing menace of the Big C, treatment cost of cancer is crippling the economically lower middle class and poor classes of the society. Early detection of cancer is the key to tackle this dreaded disease. Due to paucity of specialized Cancer hospitals and Cancer detection facilities , Rotary Club of Pataliputra, has planned to set up a mobile Cancer detection Van and conduct Cancer screening camps in the hinterland of Bihar , outskirts of Patna. This van shall be equipped with ultrasound machines, Analog Mammography machine, Dental Chair for oral cancer detection, Pap Smear Testing kits, printer, needle destroyer and other allied equipment. This van shall be staffed with technicians from Mahavir Cancer Institute and Research Centre. Mahavir Cancer Institute and Research Centre (MCIRC) is a Charitable specialized Cancer hospital, managed by Mahavir Mandir Trust. All patients testing positive during such screening camps shall be referred to MCIRC for further treatment MCIRC has agreed to treat patients below 18 years free of cost and above 18 years at 50% subsidized costs

Project planning

Describe the community needs that your project will address.

Bihar is a backward state with very high incidence of cancer . There is very little awareness amongst the people and the government hospitals are not fully equipped with specialized equipment to detect and treat cancer patients. A few private facilities are there, but the costs involved are beyond the reach of common man. Studies show that there are more than 100,000 cases of cancer reported every year. The huge population of Bihar requires 20 Dedicated Cancer centres. Diagnosis is the stepping stone for cancer treatment and prevention and our Mobile Cancer Van will increase the existing facilities, which are still minimal in Bihar and the service angle of Rotary will certainly make it more affordable for the needy.

How did your project team identify these needs?

Our Club has been involved in cancer awareness and detection camps since long and the statistics made available by National Cancer Registry Board and other medical experts and a general awareness of the infrastructure available helped our team to identify these needs.

How were members of the benefiting community involved in finding solutions?

Rotary Club of Pataliputra is already involved in cancer awareness and detection work and they had been approached by Mahavir Cancer Institute and Research Centre with their expertise of how to set up a proper Mobile Cancer Van. The planning etc has been done in consultation with them.

How were community members involved in planning the project?

The idea of setting up the Mobile Cancer Van came up from Mahavir Cancer Institute and Research Centre. Rotary Pataliputra was ready to be a resource with Grant help subject to their arranging space, making necessary infrastructure and then laying out the equipment needs. They arranged for quotations from various vendors which were submitted to us and gave their opinion on quality also. On basis of that, Rotary Pataliputra prepared a comparative chart and prepared the budget accordingly.
