A formal request for support in the management and authorisation of the construction of a seawater desalination plant and the improvement of potable water supply in the city and port of Salina Cruz, strategically located on the Pacific Ocean coast.

The execution of this project is proposed to be carried out by a national or international company specialising in advanced desalination technology, with extensive experience in water infrastructure projects at the international level.

Motivation and Justification for the Project:

- The growing residential, industrial, and commercial demand for potable water in the region requires immediate and sustainable solutions.
- The city's coastal location makes it an ideal site for this type of facility and a key component of the Interoceanic Corridor of the Isthmus of Tehuantepec.
- The current water scarcity, exacerbated by the effects of climate change, demands an urgent response.
